Sales Representative Agreement

Agreement

The purpose of this agreement is to establish, define, indemnify, protect, and control the business entities, it's names, logo's, trademarks, patents, products, services, methods, procurement, marketing, sales, and all other facets of business specifically and not specifically defined within this document throughout all phases of business and activities between the signed parties, and their associates, known and unknown.

Definitions

For the purpose of this document a Sales Representative and Sales Consultant are defined as a person or persons authorized to engage in the sale of kid'z Corner products. A Kid'z Corner principle is defined as Jon Rhodes, Gina Rhodes and, or Jon and Gina Rhodes.

Authorization to conduct sales transactions of Kid'z Corner products becomes effective with the signature(s) of both the sales representative(s) and one or more Kid'z Corner principles.

Exclusivity of venues, events and organizations is the permission to operate with the exclusive relationship between that sales representative and those venues, events and organizations defined within their agreement addendum, and remain in force until it is abandoned or the sales representative is in violation of agreement.

Credit Line is the credit extended by Kid'z Corner to Sales representatives to help sales representatives minimize out of pocket expenses while engaged in the sales of Kid'z Corner products. Credit lines have a defined amount limit and repayment time frame.

Conduct as a representative of Kid'z Corner. A sales representative will at all times as a representative of Kid'z Corner conduct themselves in a professional, ethical and legal manner that is in alignment and supports the beliefs, purpose, goals and objective of Kid'z Corner.

Violations of agreement can occur if a sales representative sells products outside the agreed upon retail or wholesale pricing structure. Violates a credit line condition, exclusivity agreement, fails to collect sales tax when stated within their agreement or conducts business in an inappropriate, unethical or illegal manner.

Termination means authorization to conduct business and or act as an agent or representative of Kid'z Corner must cease immediately and completely until reinstated. Any and all products, materials and tools must be surrendered. Termination notice can occur in writing or verbal form by mail, Email, phone or in person.

Terms and Conditions

Upon completing registration and achieving approval Kid'z Corner will provide at the request of the sales representative event, venue or organization exclusivity for events, venues and organizations if after a review of the request concludes the event, venue or organization is appropriate to conduct business and is not currently exclusive for online or physical events, venues and organizations.

Once approved, while active, this agreement authorizes you to resell approved products at predefined prices for the business "kid'z Corner" originating in Boise, Idaho, a registered business.

Authorization to conduct sales transactions of Kid'z Corner products will remain in force unless one or more of the following events occur, whereas authorization may be temporarily or permanently terminated. Selling of Kid'z Corner products at prices outside the approved price range, not paying balance of credit line as agreed, selling other products while representing Kids without prior notice.

The business "Kid'z Corner" is defined as Kid'z Corner, Kidz Corner, Kid'z Corner & Just for Women, Jon Rhodes, Gina Rhodes, or Jon and Gina Rhodes.

Exclusivity to specific event's, venues and organizations will remain in force as long as they continue to be serviced and the sales representative is in good standing with their venues and Kid'z Corner. In the event a sales representative forfeits their exclusivity or their exclusivity is terminated. A sales representative cannot transfer or give in any way exclusivity to any other person without the approval and written consent of Kid'z Corner, or its principals.

Kid'z Corner original name, logo, trademarks and sales and marketing materials shall be followed. If a sales representative chooses to modify originals or create new sales or marketing material, Kid'z Corner allows for this flexibility when all current or future market materials have been approved in advance, if they deviate in any form from the originals.

By signing this document you authorize Kid'z Corner to perform a credit check, background check and DMV check at anytime with or without advance notice or request, written or verbal and hold harmless of any outcome or resulting event.

By signing this document you acknowledge you have read and understood this agreement in its entirety and agree to hold harmless Kid'z Corner and it's principles from any actions taken on your behalf.

Termination

Termination of authorization – Termination can occur as outlined within the conduct and violation definitions listed within. Upon termination of this Agreement all items provided to the sales representative, including but not limited to documentation, customers, products, materials and training shall be return to Kid'z Corner immediately. Copies or other forms of reproduction of documents are prohibited.

Termination of exclusivity - Termination can occur if the exclusive venues, events or organizations have filed multiple complaints and have been found to not be satisfactorily resolved. If a venues, events or organizations have not been supported or active for 90 days or longer, without notice to Kid'z corner in advance that would allow for interim support.

Termination of credit line - Termination can occur if the terms, conditions and agreement of the credit line have not been met. If the credit line is in default, if termination of authorization has occurred or termination of exclusivity has occurred.

Non-Competition provision

Intellectual knowledge use, whether in methods, techniques, or information are private and confidential and may in no way be reproduced or used without written permission of Kid'z Corner principals, Jon Rhodes, Gina Rhodes and Jon and Gina Rhodes.
